We, the undersigned negural persons of the age of 18 years or more, acting as incorporators for the purpose of creating a nonprofit corporation under the laws of the State of Colorado, as contained in Article 20 of the General Statutes of Colorado, entitled "Corporations Not for Profit", and the amendments thereto, do hereby set forth:

- 1. Name. The name of the Corporation is The Athletic Association of Black Forest, Inc.
- The period of duration of the Corporation shall Duration. be perpetual.
- The purposes for which this Corporation is to Purposes. be formed are:

 - (d) To do and engage in any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or subtillar to any of the objects and purposes hereinbefore enumerated; or calculated directly or indirectly to promote the interest of the corporation in carrying The corporation in carrying and the purpose of furthering and the

of its ideals and purposes, to do any and all acts and things to exercise any and all other powers which a natural person could do or exercise and which are now or may hereafter be suthorized by law.

- 4. Membership corporation. The Corporation will be of one class; designated as "General members", who shall pay such dues as may be prescribed by the Board of Directors.
- 5. Election of directors. Directors of the Corporation shall be elected in the manner provided by the Bylaws.
